To San Francisco Controller:

Claim against City and County of San Francisco, Dept. of Homelessness + Supportive Housing (HSH); Dept. of Public Health; Dept. of Public Works; Dept. of Tax + Treasury's Financial Justice Project; Healthy Streets Operation Center (HSOC); SFPD; Human Rights Commission; Homeless Oversight Commission; Our City Our Home Commission; and City Subcontractors: Atlas Tow; Heluna Health (HOT); Episcopal Community Services (ECS); Urban Alchemy (UA); Bayview Hunter's Point Foundation (BVHPF); and Meals-on-Wheels

- 1) **Forced Sedentarization of Ethnic Nomad:** liberty interest to "establish a home" per *Meyer v Nebraska* 262 U.S. 390 (1923); privacy and freedom of expression in that "motorhome is a hybrid vehicle with most of the privacy rights of a house" per *Cali v Carney* 471 U.S. 386 (1985); right to travel to be "stigmatized Bay a state as indigents, papers, or vagabonds to be relegated to an inferior class of citizenship" per *Edwards v California* 314 U.S. 160 (1941)
- 2) **Conspiracy under Colour of Law:** failure to follow Appendix P of SF Building Code = no qualified immunity by those directly involved;
- 3) **Violation of Bodily Integrity:** Forced to Relocate to a Dangerous Location Maintained with Deliberate Indifference = 14th amendment right to due process; see generally Flint, Michigan
- 4) **Involuntary Servitude:** collection of funding for ONE records thus grants; altering government records;
- 5) **Elder (Financial) Abuse:** failure to give funding to "services" up to and including an ADA-Reasonable Accommodation December 2024
- 6) **Unfair Business Practices:** written policy of assisting only to non-vehicular housing = fraud and discrimination of an unpopular *ethnic* group;
- 7) **Intentional Interference w/ Prospective Economic Relief;** 4.15.21 until 12.24.24  
By non-profits for case plan funding: repairs, smog, registration of two (2) vehicles; relocation funds;

- 8) **Intentional Infliction of Emotional Distress:** since 11.13.97;
- 9) **Public Deceit:** Mayor's official statement that vehicle dwellers are receiving repairs and relocation to the RV park of their choice;
- 10) **Libel** (twice) ;
- 11) **Vicarious Infliction of Hostile Living Environment;**
- 12) **Intimidation of Occupation;**
- 13) **Racketeering.**

NOTICE has been sent 1.22.25 to California Attorney General of my facial and applied challenge to SFPD 97 and SFMTA 7.2.54 as being neutral in language but causing irreparable damage to my race. They are weaponized curfews that are not narrowly tailored to any stated state interest, have overbroad discretionary use (by HSOC and SFPD), nor do that have a time/place/manner exemption clause, making them entirely indefensible, especially since on appeal (pro per), I will seek strict scrutiny, since SFPD 97 directly addresses life-sustaining activities. No law like this can withstand that kind of application, especially not in light of how I will be able to apply the standard of deliberate indifference to the trauma I have endured under the "care" of the City's agents. While some of the matters under this claim are inside (attached) HUD claim filed 10.01.24, by a perusal of HUD's handbook about Conciliation, I can stay within that process until the day that the trial begins for this instant claim.

Damages sought under *42 U.S.C. Section 1983*, time frame begins the night before my wedding 11.13.97 due to that being the first time I ever experienced a "sweep"; however, primary focus to to prove City policy of extreme bias to nomadic people (making SF a "sundown town" to gypsyTravellers) is 11.16.20 to 1.22.25 as exploring official genocidal tendencies (no matter how facially-neutral the language is) as a pattern, practice, and policy has no statute of limitations.

*42 U.S.C. Sec. 1983* for the Pattern and Practice of Disparate Treatment towards plaintiff in violation of the Fair Housing Act at *42 U.S.C. 3617*; Coercion *24 U.S.C. 100.400*; the federal anti-genocide statute *18 U.S.C. 1091*; Conspiracy to Deny Rights Under Colour of Authority *18 U.S.C. 241 + 242*; and is a scheme of "involuntary servitude" as defined under *22 U.S.C. 7102(3)+(8)*

I will be alleging were violated as it pertains to vanquishing City's qualified immunity and to highlight the legal obscenity in SFPD 97 of being given a "license" to exist, but now it's a property right with its denial deserving of due process; see generally *Goldberg v Kelly* 397 U.S. 254 (1970):

Intentional Infliction of Emotional Distress

Time frame of this case: the anti-genocide code has no Statute of Limitations, thus I will be going all way back to the first “sweep” by SFPD on 11.13.97 and my wedding stopped by same at Golden Gate Park 11.14.97, as well as the entire CPS debacle led by Katherine Feinstein and Kamala Harris 1998 - 2001 which included (in a court petition) the words, “Due to your family's nomadic propensities...”.

So, again, the time frame of this case: 11.13.97 to 1.20.25

**Actual Damages:**

#1) Emotional Distress 8.9.22 to have been forced into the VTC because I had HSOC (on tape) use threat to impound my RV as well as comments about me having to seek institutionalized hospice in the event of impound;

#2) Emotional Distress of having had my school bus home impounded 8.14.06 by SFPD (thus PTSD for #1 must be added in as damages, too)

#3) Emotional Distress for loss of autonomy for self-determination of terminal cancer needs, inc. death at hands of Dept of Homelessness and sub-contractors, directly due to a pattern of false promises 4.15.21 to 1.20.25 by all tiers of the Dept of Homelessness and their subcontractors;

#4) Property Damage to current vehicle home (1996 Gulfstream Class C RV, 28' long): on 8.9.22 the RV tow (by Atlas Tow) from Ocean Beach to the VTC in Bayview inverted and bent the rear leaf springs and cracked the control arms → 3.8.24 the leaf springs were replaced/ vendor refuses to address the control arms and other issues that resulted from half-repairs (and being ignored at VTC for 29 months); Nov-Dec.2023 damage by vendor to roof, windows, and body of RV; 3.8.24 failure to finish repairs due to “funding drying up”; 12.3.24 damage to roof and failure to complete repairs by current vendor; damages from uncontrolled rats;

#5) Emotional Distress and Physical Sickness from having been exposed to the toxic dirt of Hunters Point Shipyard, particulates from 16 unpermitted generators, and the repeated aerosolization of rat feces;

#6) Emotional Distress from libel in two ways: #a) the closing report for the Financial Justice Project's funding of the \$100,000 repair fund embezzled by sub-contractors (note I will be including the way my name - and other residents- were NOT redacted from a public document); #b) December 2024 hit piece about the VTC where I - and others - were, to quote an anonymous Urban Alchemy staff member, "entitled troublemakers" "leeching resources" and "in their mobile homes squatting on our property";

#7) Emotional Distress from being made to sign away my housing rights in the 8.9.22 "safe parking program" Participant's Agreement: i.e. stoves, heat, hot water, refrigerator (due to the required surrender - volunteer or otherwise - of our propane bottles; no replacement kitchen or refrigeration; no electricity given until Jan; no rat control; foul and fraudulent food trays; no ADA parking (abused over this on 12.7.23 which I taped); pattern of Invasion of Seclusion; ignoring multiple ADA Reasonable Accommodation; and promoting a hostile living environment because I formed a tenants union (specifically I plan to show how closing the VTC is a response to my filing the appeal of the matter of *being* a tenant or a guest;

#8) Emotional Distress and Physical Deprivation of Nutrition by not only the inability to cook (by the rules and the signing of the move-in agreement to disconnect our stovetops and the confiscated propane), there is also the taking of my foodstamps, which should be \$279 (if I lived at a normal RV park —> the goal of my program participation) but are only \$28 because I live at VTC for 29 months = a loss of \$ \$7,250 total;

#9) Emotional and Actual Damage to be denied the ADA Reasonable Accommodation of getting RV repairs, smog, and registration due to unlicensed, inept mechanic hired 12.3.24 who substantially abandoned the repairs that were invoiced for \$13,000 plus told I need to sign a "Hold Harmless" Agreement 1.\*\*.25 in order to obtain smog and DMV costs of \$2000; \$499 fraudulent invoice by sub-contractor and vendor;

#10) Emotional Distress from the False Imprisonment (by failure to repair) and then to know the likelihood of having RV towed on street in spite of TWO documents by Dept of Homelessness and Urban Alchemy stating I can drive away (no registration necessary); no appeals process in spite of filing dozens of grievances since 5.1.24;

#11) Emotional Distress from hundreds of police "sweeps" since 11.13.97 as a pattern and practice of Intimidation of Occupation;

#12) Emotional Distress from being told - and attempted to punish me 6.3.24 by banishing me to streets for 30 days to be in danger of seizure of my vehicle - because I film the abuse of my neighbors and myself at the hands of the City and their subcontractors and vendors; group chat message stating: "I know it's not what we wanted but there is a directive to fully fall back on Ramona"; seizure of SUV Oldsmobile Bravada on 8.1.24;

#13) Emotional Distress of having been lied about by CPS from 5.1.98 until 6.3.01 (book published on Amazon in 2017 about it called "Collected Letters from the Abyss");

#14) Stopping my wedding 11.13.97 because I lived in a school bus parked on the edge of Golden Gate Park (essay in my book out 2016 on Amazon: "Nomadic Proud");

#15) Emotional Distress of having my ONE records altered 11.08.23 two weeks after I began collecting signatures for a tenants' union;

#16) Emotional Distress of being asked (taped) 3.7.23 where my faith is by City's subcontractor Bayview Hunter's Point Foundation woman in charge of releasing 2023 repair fund from City's Financial Justice Project. Their subsequent and collective libel in the closing report for fund.

#17) Emotional Distress that I have to sue the most progressive city in the world to get the dignity to die in my own home, no matter where I park it, whether broken, registered, or mobile.

#18) Emotional Distress of being denied visitors in my home since 8.9.22 (29 months) while I am facing terminal cancer.

## **Demand**

Amount that would make me whole, for three decades of hate by San Francisco, who in 1971, created a second class of citizenship and put me in it 11.13.97 til 1.22.25, essentially ruining my life - as I knew it - because I am an ethnic gypsyTraveller, is **\$846,300,000** which is the equivalent of the Dept of Homelessness 2024 budget ... all I ever asked for 2021 to 2024 was approximately \$4500 in case plan funding ... approved for over and over and over then it always just ... ..vanished until sedentarization was forced on me and now my RV is beyond repair and I more close than ever to dying because City forced to me (by way of the SFPD 97-based license) live for over two years in an internment camp next door to a NPL Superfund site, with constant soil disturbance 20' from me and my pets, without notice..

*Alternatively,*

Remove SFPD 97 entirely and the misplaced ability in SFMTA 7.2.54 to tow "oversized vehicles";

Immediately begin converting 10% of Park and Rec property to sliding scale campgrounds for both tents and RVs, solar powered (only);

Create a Dept of Vehicle Dwellers inside the Dept of Human and Health Services (RVs literally do not meet the definition federal or state definition of Homelessness);

Dept of Vehicle Dwellers will put the proper resources into a physical location that repairs our vehicles, smogs, registers, pays move-in costs and subsidies to RV parks; and make sure Appendix P is adhered to surrounding RVs inc. Kitchen access at VTC;

Automatic \$ debit card at building supply for items to winterize/ repair interior upon entry of all RVs into the (new)Dept of Vehicle Dwellers

Allow the vehicle dweller into the private housing market;

Signed and dated WRITTEN case plans with an appeals process for all HSH clients;

Foodstamps not taken because someone is in the VTC or any HSH site;

Policy change to never deprive anyone of cooking, heating, hot water, visitors, and 100% privacy (i.e. schedule anything);

Panel with Residents on it to judge who gets evicted from "safe parking programs";

\$7,250 replacement food stamps (or on a debit card);

Debit card with \$13,000 current repair invoices (12.3.24) and \$2,000 smog/DMV costs so I can effect the work myself with real mechanics (total \$15,000);

and \$7,000,000 cash.
